RA HARVEST PRICE ANNOUNCED

The USDA Risk Management Agency set the 2011 Crop Insurance Price Elections for canola at \$26.30 per hundredweight. 2011 is the first year of the new Common Crop Insurance Policy (Combo) that replaced APH and Revenue Assurance for various crops. Producers had the option of choosing Yield Protection, Revenue Protection, and Revenue Protection with the Harvest Price Exclusion.

MCC/NCGA JOINT RESEARCH COMMITTEE

MCC and NCGA have a joint research advisory committee that determines the most productive allocation of available research dollars, including North Central Regional NCRP and Sclerotinia Initiative funds. The committee meets annually and includes two producers and industry representation from each state. 2011 CANOLA PRODUCTION CENTRE (CPC)

The 2011 CPC was located north of Northern Resources Cooperative on the west side of Roseau. While early-season moisture stress was observed on a small portion of the site, most studies had good growing conditions and produced average to above-average yields.

The 2011 CPC was planted on May 18 and 19. Seedbed conditions were near ideal at planting, and timely rainfalls 4 and 11 days after planting resulted in excellent stand establishment. Slight moisture stress was observed in some plot areas shortly after herbicides were sprayed

on June 16, as rainfall events on June 18, June 21-22, and June 26-27 deposited 0.66, 1.29, and 0.81 inches of rainfall, respectively. However, rainfall and temperature conditions were near ideal throughout the rest of the growing season. Public trials included the small-plot variety & systems trial; a nitrogen, sulfur, and boron fertility trial; a date of planting trial conducted in conjunction with NDSU; and a harvesting methods trial.

The Council continues to rely on its CPC for valuable agronomic information. The information garnered from these trials is intended to offer producers scientific, easily adaptable information to help them produce canola more efficiently and profitably. MCC PARTICIPATES IN SEED MEETING IN AITKIN - JANUARY 2011

MCC participated in a seed meeting held at the Moose Lodge in Aitkin, MN, in January 2011. The meeting was sponsored by Aitkin Feed & Farm Supply and featured agronomic information about a number of crops including corn, soybeans, and canola. With over 30 people in attendance, participants heard first from Jon Dockter, Associate Director of MCC, who talked about the mission and activities of the Council, as well as crop insurance and market prices. A grower panel discussion followed featuring three MCC board members - Curt Amundson and Mike Hagen of Roseau, and Rob Rynning of Kennedy. The discussion gave attendees the opportunity to ask questions of and talk with growers who, combined, have close to 50 years of canola growing experience. This was the second time the Council participated in the Aitkin seed meeting. These meetings are intended to provide growers with agronomic, economic, varietal, and rotational information to allow them to more easily incorporate canola into their rotations.
